Pastor Phil gave a history of the Church and described the schedule they have for services and meetings. He stated that Waste Management picks up the trash and recycles once a week and they have no problems.

Mr. Mascione gave testimony regarding the overall project design as it is now and with the addition. The existing church and the auditorium would not be used at the same time except for the newly constructed nurseries.

Ms. Boave, P.E. gave testimony regarding the existing and proposed site conditions. She stated that there would be no parking changes. She then discussed the changes to the drainage and the building.

The applicant has requested waivers for the curbing and sidewalks. Board member Purdy asked about the fees for such waivers. The applicant would be required to pay 50% of the cost of installation. The applicant owns 2 lots and may only be required to place the sidewalk on the lot that the Church is located on. The applicant will work with the board Engineer/Planner with the curbing and sidewalk contribution as well as a possible rain garden.

Ms. Boave then discussed the parking variance that is being requested. She stated that the increase of the building area is not going to increase the number of members. They know that if they need additional parking they will have to come back to the board.
